The cemetery fence has now been repaired and will be repainted within the next week.

The cemetery contractor to repair hole in fence near the new ashes section shortly, after concerns regarding anti-social behaviour from youngsters visiting the Cheveley Park Play area next door.

Councillor A.C. Walker raised a concern regarding Broomside Road/Belmont Road junction, querying if blocking the hatch signs at the junction would deter the speed of traffic joining Belmont Road from Broomside road. He said residents were asking for a chicane on Broomside road.

Carrville

A request for double yellow lines at the newly installed crossing on Carrville High Street as drivers were seen parking their cars there causing Health and Safety issues.

It was reported that residents were concerned about the new bus route provision by Go North East.

The Chairman informed Councillors he had requested three bus shelters, one on Broomside Lane, The Belmont Arms and one near B & M.

A concern was raised regarding overflowing bins at Pickering Place.

Councillor Fletcher said she had met with officials and several issues were raised concerning weeds, untidy green, old garages, and street lighting in Broome Court.

Gilesgate Moor

It was reported that some residents were unhappy with the state of the footpaths after the recent removal of telegraph poles by Netomina.

The Chairman informed Councillors that removal of weeds in gutters throughout the parish would begin presently by Durham County Council.

It was reported that double yellow lines and hatches were needed on the new road where MKM Building Suppliers are situated as drivers were reportedly sitting in their wagons there causing obstruction.

It was reported that Belmont United were looking for funding as they had one hundred youngsters attending sessions on Monday evenings. The Chairman advised an e-mail be sent to the Parish Office regarding their request.

The Chairman advised Councillors to report any concerns themselves via Durham County Councils facility doitonline.
